HC castigates VMC, summons civic chief

Vadodra/Ahmedabad: The Gujarat high court on Friday pulled up the Vadodra Municipal Corporation (VMC) and summoned its commissioner to explain the body's digging up of a stretch of a road in Alkapuri after the corporation decided to return the land it was on to a developer, without paying any compensation even after using it as a public street for over five years. The bench of

Chief Justice Arvind Kumar and Justice Ashutosh Shastri came down heavily on the VMC for its recalcitrant stand, "In normal course we would not have directed the commissioner to appear in court. However, because of the recalcitrant stand taken by the corporation contending that the road which was in its possession has been resolved to be returned, or not (being) willing to utilize the land of the road for public use, we are forced to call upon the commissioner to appear in person." The court has posted a hearing of this case for February 28. The petition was filed by Shree Maruti Developers, claiming that VMC had taken possession of 2,019 square metres of its land in 2017 to expand a public road but did not pay any compensation.

More than five years later, in March 2022, VMC decided to return the land, which the developer did not agree to because its construction was already put up to suit the widened road. The developer urged the HC to suit the VMC's decision to return the land. The HC sought a reply from the VMC in this regard. However, the VMC on Thursday dug up the road and the petitioner informed the court about it. The judges were furious and sought an explanation. To this, VMC's counsel argued that the decision to widen the road was reversed and hence the land was being returned to the original owner. The chief justice asked VMC who used pay compensation for the use of land for more than five years, calling this VMC's fallacy.

Leader of opposition Congress in VMC, Anirudh, said, "We had said in 2016 that the civic body will find it difficult to compensate land owners for the massive road widening work it had taken up. If all seek compensation from VMC, the total amount will be more than Rs 450 crore and Rs 500 crore. But the VMC remained adamant and passed the matter using its majority," she said. Those who have shops in the Harmony Complex located on the road have also objected to digging and submitted a letter to VMC commissioner and are exploring legal options.

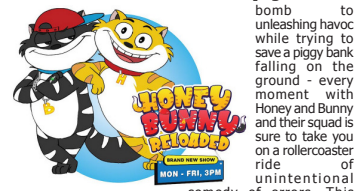

Gujarat's MMR steadily over last five years

Gandhinagar: The maternal mortality rate (MMR) in Gujarat has been dropping steadily in Gujarat over the last five years, reflecting an improvement in risk associated with pregnancy among women.

Figures provided by the Union government in the ongoing budget session of parliament said that according to the sample registration system (SRS) figures, the MMR in Gujarat fell from 87 in SRS 2015-17 to 57 in SRS 2018-20. MMR is defined as the number of maternal deaths per 100,000 live births due to pregnancy or termination of pregnancy. The maternal mortality rate is used to represent the risk associated with pregnancy among women. According to SRS 2018-20, Gujarat is placed 13th in the country, with 12 other states having a MMR higher than that of Gujarat.

Tea-stall owner alleges torture in police custody

Rajkot: A tea-stall owner, who was arrested on an attempted murder charge on February 7, has accused the B-division police of physically torturing him and his son inside the lock-up, allegedly at the behest of the man who had lodged a complaint against him.

Zina Gohel, the tea stall owner, and five other people including his two sons, were arrested for allegedly harassing restaurant owner Hardik Kugushiya on Palace Road on February 7. The fight began when Kugushiya asked Gohel's brother and sons not to use abusive words in the public place and refrain from making noise during the night.

Kugushiya alleged that Gohel stabbed him and his sons beat him with pipes and sticks. Meanwhile, Gohel made the allegations of torture before the court when he was produced for custody on Thursday. The court ordered police to admit him to the civil hospital for treatment.
