PHARMACEUTICAL GIANT Cipla, which has been at the forefront of manufacturing Covid-19 drugs in the country, has taken cognisance of a complaint received from a Vadodara resident regarding its drug Foracort -- used to control symptoms of asthma — after a patient claimed to have received empty rotacaps of the drug in a recently purchased bottle from a druggist in the city.

In his complaint to the Drug Safety team of the company as well as to the National Consumer Forum, Vadodara resident Mrudang Thakor, has stated that his 62-year-old father has been using Foracort for several years on the prescription of a senior chest physician for treatment for Asthma.

'My father has been an Asthma patient for the last 25 years. He has been taking Cipla's Foragort for many years which

was prescribed to him by a renowned chest physician of Baroda. He regularly purchases Foracort from nearby pharmacies. On August 20, he purchased a pack of Foracort Rotacaps from the Subhanpura branch of a pharmacy. Ever since he started taking the rotacaps using the rotahaler device, he started feeling breathlessness and he was feeling as if the medicines were not working at all,"Thakor has said in an email to Cipla's Drug Safety team.

The family also considered Covid-19 as being a possible cause of Thakor's father's persistent breathlessness before deciding to check the new consignment of the drug. Thakor said, "I was almost ready to seek treatment for my father for Covid-19 but I decided to check his medications when I felt something was not right. Upon checking, I found that the rotacaps that he was consuming were totally empty. My father had been taking the empty capsule shells of Rotacaps for close to two days and his health had deteriorated.

Thankfully, once we noticed this we brought proper drugs and he is doing much better."

The family, however, contacted Cipla, raising questions on the product quality. "I don't know what health damage those empty capsules have done to my father. What if this results in a serious problem in the future?... I want a fair investigation into the matter and I also want fair compensation for this mishap," Thakor has said in his email to Cipla. The company, Thakor said, deputed a senior executive of the Respiratory Medicines department to look into the issue and has assured the family of completing their investigation into the issue by September 1.

The company also confirmed that it had collected samples of the capsules from Thakor's purchase for a "thorough investigation".

A Cipla Spokesperson told The Indian Express in an email statement, "We are investigating the matter on priority, including if the product is of genuine Cipla origin.
