The daily average air quality in Delhi, for the 10-month period between January - October, 2023, registers its best index as compared to the corresponding period during the last 6 years (barring the COVID affected 2020), thus establishing a continual trend of relative improvement in air quality of Delhi-NCR.

In Delhi has been about 1.73 ug/m3, which is much lower than a range of 182-220 ug/m3 during the corresponding periods from 2017 to 2022 (barring the COVID affected 2020).
